Certification Mark(s) shall not be used or registered as or incorporated in social media account names, profiles, or aliases.

Permission to use the Certification Mark(s) is limited to the Licensee, and shall not be transferred to, assigned to or otherwise used by any other individual, organization, or entity.

CERTIFICATION MARK USE GUIDELINE

The Licensee shall desist of any action that would constitute a breach of Certification Mark Licensing Agreement or misuse of Certification Mark(s), and remedy any breach or misuse without undue delay.

At least the following actions constitute a misuse of Certification Mark(s):

- a) placement of the Certification Mark(s) on products or use to distinguish products, services and processes that are not certified and thus shall not bear the Certification Mark(s);
- b) any imitation or change of the Certification Mark(s);
- c) use of the Certification Mark(s) in a form that differs from the one provided;
- d) use of the Certification Mark(s) in a way that results in Certification Body's defamation or may harm its reputation.

In case of misuse the Certification Body may, in its sole discretion, choose between one or more of the following actions:



- a) suspend the use of the Certification Mark(s) in part or in full until compliance with Certification Mark Licensing Agreement is re-established; and/or
- b) make a public announcement of misuse; and/or
- c) inform the Supervisory Authority about the misuse of the Certification Mark(s), where the severity of the case imposes such action, and/or
- d) take other necessary measures suitable to remedy the breach, including but not limited to filing for temporary injunction with any court or arbitrator.

In case of any misuse of the Certification Mark(s), the Certification Body shall notify the Licensee to take corrective action.
